COURSE DESCRIPTION

This course begins the DNP project phase of the program. Students will incorporate content from the DNP core courses to successfully plan and develop and evidence-based doctoral project. Utilizing the SQUIRE guidelines, sections 1-6 of the DNP project manuscript (T)-0.1E .cIT (m)0.7 (oj)Tc -0.0f.3 (t)2.3 (e)4.47 (r)2.7pTc - the problem, available knowledge, rationale, and specific aims of the project. The DNP project team will be formed with a DNP project advisor and team member. Students will be prepared to present their DNP project proposal to the DNP project advisor, DNP project team, and their peers by the end of the semester. Approximately 145 experiential engagement hours aligned with the AACN DNP Essentials will be completed in this course.

At Wilmington University, Satisfactory Academic Progress (SAP) in the Doctor of Nursing Practice (DNP) program is defined by the following three criteria:

1. Earn a B or better in all DNP courses.
 - a. If less than a B is earned in a DNP course, students can re-take the course one (1) time.
 - b. A maximum of two (2) courses may be repeated.
2. Maintain a 3.0 GPA or higher.
3. Complete all degree requirements within seven (7) years.

Failure to meet these requirements will result in academic dismissal from the program.
