Structured External Assignment:

This course has covered many factors that contribute to the health and wellness of children during the early childhood years. Communicating with families is an important part of cultivating relationships that promote wellness, and, part of doing so, is clearly and thoughtfully explaining center or school policies.

Then **create** a presentation using the format of your choice (PowerPoint, Prezi, ect.) to be used as an orientation for parents explaining your policies.
