- A-2 Compare and contrast the medical model of chemical addiction to the Bio-Psychosocial model of addiction.
- A-3 Analyze and discuss the criminal justice systems response to the disease model of addiction as well as the Biopsychosocial model of addiction.

## **GOAL B:**

Students will develop an understanding of the psychopharmacology (how these drugs are introduced into the body, enter the circulatory system, produce their effect and are then eliminated) of the popular substances that are utilized by criminal justice offenders as well as victims of crime.

- B-3 Conduct a review of Stimulant use.

- B-7 Conduct a review of Phencyclidine use.

## **GOAL C:**

Students will develop an understanding of the various screening and assessment tools as well as the referral process that is currently being utilized in the field of addictions.

- C-1 Develop a basic understanding of the basic components of Motivational Interviewing strategies and be able to apply how Motivational Interviewing creates an incentive to change behavior.
- C-2 Evaluate the following screening and assessment instruments utilized in the field of addictions (MAST, CAGE, AUDIT, DUSI, Addiction Severity Index and SASSI).
- C-3 Analyze case studies to determine the appropriate level of care as outlined by the American Society of Addiction Medicine (ASAM).
