This course is a survey of the current budget practices among all levels of government in the United States. Methods are emphasized, along with the sources and types of information needed in budgetary decision-making.

**MAJOR INSTRUCTIONAL GOALS and LEARNING OBJECTIVES:****GOAL A:**

This course will highlight the major differences between budgeting in the public sector versus budgeting in the private sector. After completing this course, students will understand and appreciate the various steps in the public budgeting process, including the role of the public and various constituency groups.

**Learning Objectives:** The student will:

- A-1    Compare the differences between the focus of public and private sectors budgets.

- A-4 Define the impact of externalities and pricing to public services.
- A-5 Critique the responsibility to constituents and how ethical decisions are made in the budgetary process.
- A-6 Examine budget preparation, approval, and execution processes.
- A-7 Describe financial management in the public sector.
- A-8 Examine the impact of budget decisions on domestic and international societies.
- A-9 Demonstrate the ability to think critically, and prepare and deliver clear, concise oral and written communications.
