COURSE TITLE: Abnormal Psychology

COURSE NUMBER: PSY 305

### I: COURSE DESCRIPTION

This course is a study of the causes, characteristics, and management of abnormal behavior. The course is divided into three general areas: major theoretical perspectives of abnormal behavior; major disorders following the categories of the Diagnostic and Statistical Manual of the American Psychiatric Association (DSM); and causes treatment, and impact of abnormal behavior.

### II. MAJOR INSTRUCTIONAL GOALS:

### GOAL A:

Evaluate major theoretical perspectives of abnormal behavior (Biological, Psychodynamic, Cognitive, Sociocultural and Humanistic).
